

Students with disabilities	We have created some helps for students struggling with disabilities, we have lowered the numbers in our Math classes and developed some Math co-taught classes to assist students. We are finding the Math is our toughest core class (based on pass/fail and recovery credit data and growth). We will continue to put a focus here to allow more RTI as well as math specialization help classes.
